It was regularly moved and seconded that the proposed Bylaw should proceed to second reading in accordance with the procedures set out in the <u>Municipal Government Act</u> of Nova Scotia.

#### **1<sup>ST</sup> READING FEEDING OF WILD ANIMALS BYLAW**

The object of the bylaw is to prohibit the feeding of wild animals in the Town of New Glasgow and simplify the process for administering the penalties by the New Glasgow Regional Police and/or Bylaw Enforcement Officer by incorporating the Summary Offence Ticket (SOT) designation into the bylaw.

It was regularly moved and seconded that the proposed amendment should proceed to second reading in accordance with the procedures set out in the <u>Municipal Government</u> <u>Act</u> of Nova Scotia.

# NOTICE OF MOTION TO ADOPT POLICY – AMENDMENT TO DEVELOPMENT AGREEMENT – JOHNBO INVESTMENTS – 244 TEMPERANCE ST.
